Proposal to form ICS Drafting Group

Summary

ATNP WG2 is expected to propose to ATNP/3 a number of enhancements (i.e., Package-2) to the ICS Sub-Volume V. This working paper proposes that WG2 form a drafting group to prepare a red-lined version of Doc 9705 to progress from the first edition to the second edition of the ICS technical provisions.

1. INTRODUCTION

ATNP WG2 is expected to propose to ATNP/3 a number of enhancements (i.e., Package-2) to the ICS Sub-Volume V. This working paper proposes that WG2 form a drafting group to prepare a red-lined version of Doc 9705 to progress from the first edition to the second edition of the ICS technical provisions.

2. DISCUSSION

ATNP WG2 will be expected to approve, at its September/October 1999 meeting, the final draft of the proposed revisions to Doc 9705, Sub-Volume V that will incorporate the 'Package-2' ICS enhancements. It is expected that a number of WG2 members will accept action items out of the Naples WG2 meeting to draft additions and revisions to existing Sub-Volume V text to introduce the Package-2 enhancements. It is important that we insure that the overall Sub-Volume V draft, as presented to WG2 in Sept./Oct. 1999, is complete and consistent. Also the CCB is in the process in finalizing the first amendment Doc 9705 for publication by ICAO in 1999. The proposed Package-2 revisions to Doc 9705 will need to work from a baseline where the CCB approved

Package-1 revisions (i.e., Amendment Number 1 to Doc 9705) have been incorporated into the current published First Edition (i.e., 1998) of Doc 9705.

The Working Group of the Whole (WGW) will need to review and approve changes to the ICS guidance material (i.e., the CAMAL) at the planned December 1999 meeting. It is anticipated that WG2 members will need to be contributing to the development of new and revised ICS guidance material for presentation to the WGW. WG2 will need to address the resources needed to provide complete and consistent guidance material.

3. RECOMMENDATION

- a) It is proposed that ATNP WG2 form an ICS Drafting Group (IDG) and approve the following terms of reference for the IDG:

Use Doc 9705 First Edition, Sub-Volume V, WordPerfect files from ICAO as the baseline document that will be used as the starting point for the producing the proposed "Package-2" update for WG2 submission into ATNP/3.

Incorporate the changes from Amendment Number 1, as provided by the ATNP CCB, into the baseline Sub-Volume V. This updated baseline will then be used for producing a red-lined draft of the proposed second edition of Sub-Volume V.

Use the draft guidance material for the ICS, as provided by the panel secretary in WordPerfect files, as the baseline for producing a red-lined draft of a proposed second edition of the ICS section of the 'CAMAL'.

Draft revisions to Doc 9705, Sub-Volume V, to incorporate the technical provisions for the enhancements to the ICS that have been accepted by ATNP Working Group 2.

Draft editorial changes to Doc 9705, Sub-Volume V, as necessary to clarify the ICS technical provisions and to insure the consistency of the technical requirements.

Submit the proposed Doc 9705, Sub-Volume V, Second Edition draft to the 19th meeting of ATNP WG2, being held in Spain the week of 27 September 1999.

Draft revisions to the ICS related guidance material and submit for approval, in the form of proposed red-line changes, to the Working Group of the Whole Meeting being held prior to ATNP/3.

- b) It is proposed to convene two meetings of the IDS between the WG2 meeting in Naples and the subsequent WG2 meeting in Spain. Also it is proposed to convene one meeting of the IDS subsequent to the Sept./Oct. WG2 meeting in Spain and

prior to the WGW meeting (tentatively in November 1999). The proposed dates and locations for the meetings of the ICS Drafting Group are:

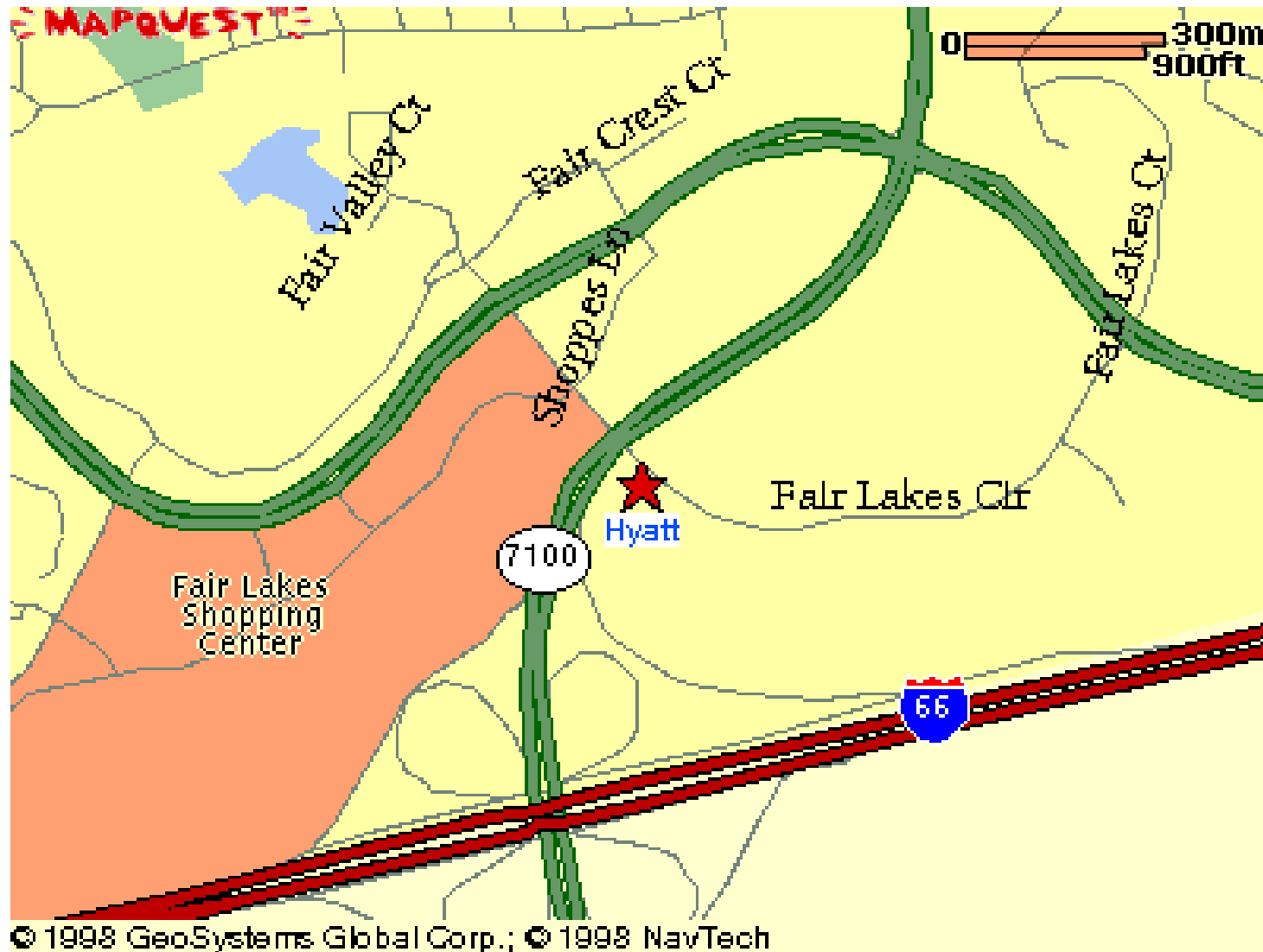

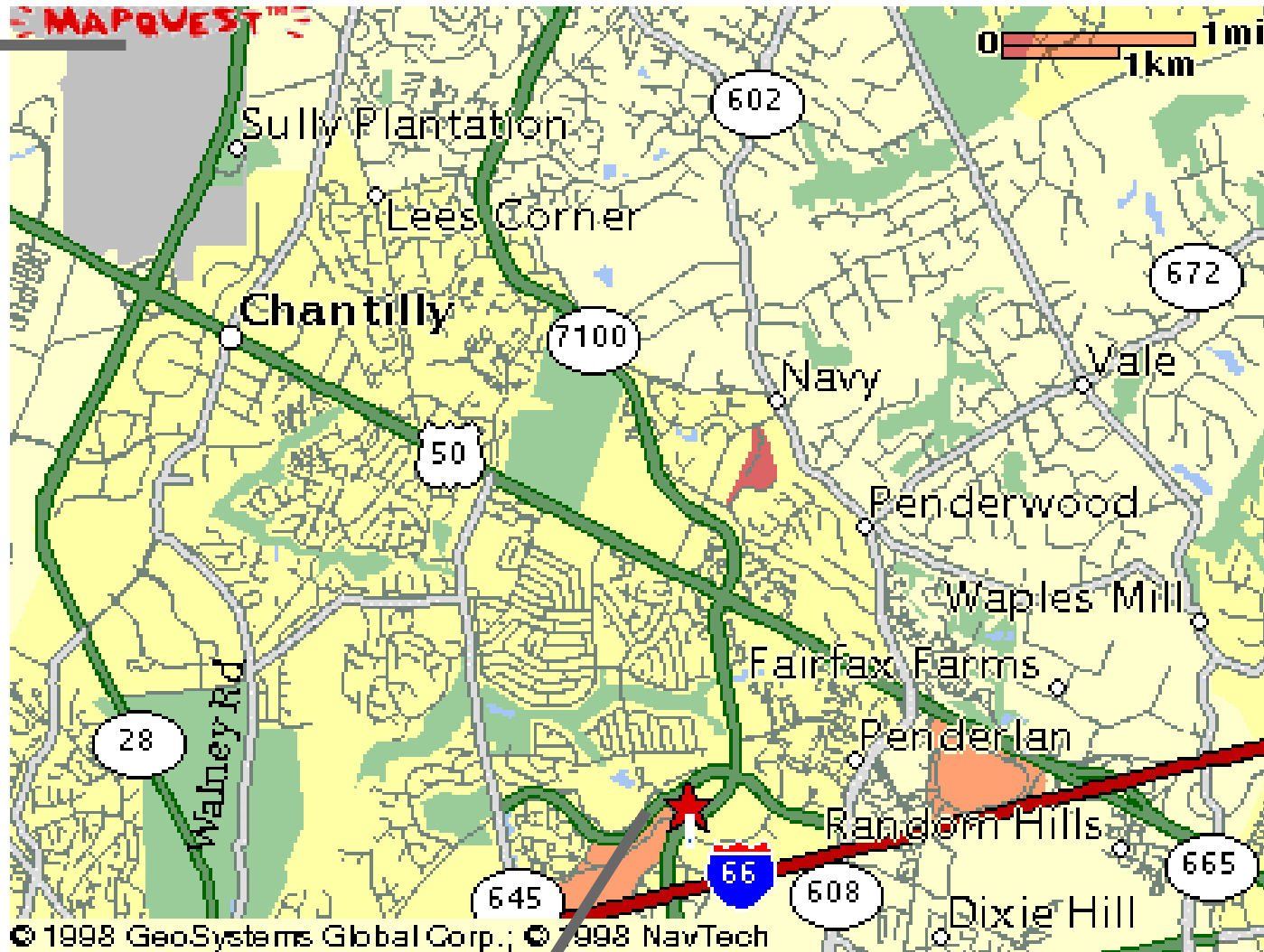
